We received the EIDL loan finally this week in the amount of \$149,900 (150K less \$100 processing fee). This is a 30 year loan at 2,75% interest rate. We also received the 2nd round of the PPP loan in the amount of \$110,607. In light of receiving both, the finance committee feels our cash flow should be good and are recommending the following:

- 1) Pay off the van loan through Ally which is around \$24,200. (currently at an interest rate of 6.24%)
- Pay the remaining of the \$149,900 toward a principal payment on our large West Gate loan from the Capital line of credit #8020034.
 (currently at an interest rate of 3% and is up for a renewal in March--we've just been paying interest monthly on this one.)
